

Step 5 File the papers.

A list of current fees is available from the Law Library Resource Center and from the Clerk of Superior Court's website. If you cannot afford the filing fee, you may request a deferral (payment plan) when you file your papers with the Clerk of Superior Court. The Clerk accepts cash, Visa/MasterCard/ American Express credit cards, money order, or business check made payable to the "Clerk of Superior Court."

If mailing your forms, place all original forms for the Clerk of Superior Court into an envelope, with the filing fee or fee deferral form, and mail it to:

(include a self-addressed stamped envelope in the envelope, so the forms can be mailed back to you)

If filing in person, go to the Clerk of Superior Court filing counter. The court is open from 8:00 a.m.-5:00 p.m., Monday to Friday. You may file your court papers at the following location:

Hand all 3 sets of your court papers to the Clerk along with along with the correct filing fee or fee deferral form. The Clerk will date-stamp all three sets, keep the original forms, and return the 2 copies to you.
