

Instructions and Procedures to file a foreign judgment

Step 1 Obtain a certified or authenticated copy of the judgment from the other court.

Step 2 Complete the required forms.

- Civil Cover Sheet
- Notice of Filing a Foreign Judgment
- Affidavit Substantiating a Foreign Judgment

Step 3 Make copies. You do not need to copy the Civil Cover Sheet.

- Make 2 copies of the following:
 - certified or authenticated copy of the judgment from the other court
 - Notice of Filing a Foreign Judgment
 - Affidavit Substantiating a Foreign Judgment

Step 4 Separate the forms into 3 sets.

Set 1: original set for Clerk of Superior Court

- Certified copy of the judgment from the other court
- Civil cover sheet
- Affidavit Substantiating a Foreign Judgment
- Notice of Filing a Foreign Judgment

Set 2: copies for the other party

- Copy of judgment from the other court
- Affidavit Substantiating a Foreign Judgment
- Notice of Filing a Foreign Judgment

Set 3: copies for you

- Copy of judgment from the other court
- Affidavit Substantiating a Foreign Judgment
- Notice of Filing a Foreign Judgment

Step 5 **File the papers.**

A list of current fees is available from the Law Library Resource Center and from the Clerk of Superior Court's website. If you cannot afford the filing fee, you may request a deferral (payment plan) when you file your papers with the Clerk of Superior Court. The Clerk accepts cash, Visa/MasterCard/American Express credit cards, money order, or business check made payable to the "Clerk of Superior Court."

If mailing your forms, place all original forms for the Clerk of Superior Court into an envelope, with the filing fee or fee deferral form, and mail it to:

(include a self-addressed stamped envelope in the envelope, so the forms can be mailed back to you)

If filing in person, go to the Clerk of Superior Court filing counter. The court is open from 8:00 a.m.-5:00 p.m., Monday to Friday. You may file your court papers at the following location:

Hand all 3 sets of your court papers to the Clerk along with along with the correct filing fee or fee deferral form. The Clerk will date-stamp all three sets, keep the original forms, and return the 2 copies to you.

Step 7 **Mail one set of forms to the other side.**

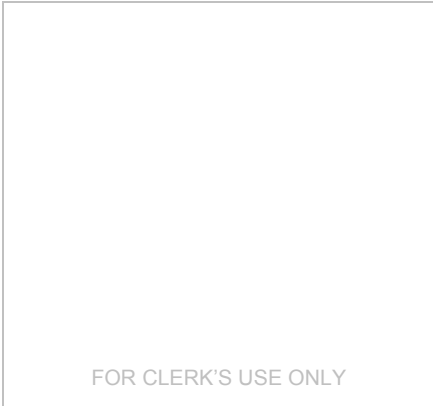
